SELECT MISSION RESULTS



In Burundi, the Incubator conducted a comprehensive partner landscape assessment, delivering a highly insightful understanding of the diverse array of organizations operating in the country. The team surveyed 784 organizations, identifying a final list of 30 partnership-ready local organizations that were aligned with USAID/Burundi's priorities.

DOMINICAN REPUBLIC Local Partner Project Turnaround

The Incubator provided intensive, inperson turnaround support to a local university partner in the Dominican Republic with an underperforming USAID project focused on higher education institution partnerships and youth development. As a result, the partner successfully hired a Chief of Party to lead the project, repaired weak interpersonal relationships, and exceeded end-of-year MEL targets.

DEMOCRATIC REPUBLIC OF THE CONGO (DRC) Local Partner Pre-Award Preparation

In early 2023, four local partners in the DRC were successfully supported in their efforts to secure their SAM, UEI, and NCAGE registrations. As a result, two organizations received noncompetitive BHA awards and then received additional Incubator technical assistance and capacity-strengthening services.
